In re: Application of Motion Law LLC

ORDER FOR AUTHORIZATION TO PRACTICE LAW IN UTAH

Amended July 6, 2023

Based upon the Utah Supreme Court's plenary and constitutionally granted authority to regulate the practice of law in Utah, and the tenets of Standing Order 15, the Utah Supreme Court orders that Motion Law LLC ("Motion Law") is authorized to practice law within the Utah legal regulatory sandbox ("Sandbox") and subject to the restrictions outlined below.

The Court has reviewed the amended recommendation of the Office of Legal Services Innovation ("Innovation Office") dated June 6, 2023.

Motion Law is an Alternative Business Structure ("ABS") authorized to provide immigration services. Servcies are provided by lawyer employees and facilitated through a software platform. The software tool provides consumers access to their case file including: status updates, documentation, events, invoices, and payment mechanisms and are accessible during attorney-client consultations. Motion Law also handles client acquisition services.

Motion Law seeks an amendment to its authorization order permitting it to provide legal services for small businesses.

The Innovation Office has assessed Motion Law's proposed entity structure, service methods, and legal areas, and has determined that Motion Law is a Low Innovation entity and that the risk of harm to its targeted consumers, relative to the risk of harm they currently face, is acceptable for authorization.

In light of the Court's responsibility to the public to effectively regulate the practice of law in Utah, and in keeping with the tenets of Standing Order 15, the Court now orders as follows:

1. Motion Law is authorized to offer legal services through the following service **methods:**

- a. ABS
 - i. Lawyers employed or managed by nonlawyer(s)
 - ii. Nonlawyer ownership
- 2. Because Motion Law is an ABS in which all legal services are provided by lawyers, it is authorized to provide services to the extent of those lawyers' licenses, subject to the lawyers' duties and responsibilities under the Rules of Professional Conduct.
- 3. Motion Law shall conform to the Low Innovation reporting requirements imposed by the Innovation Office.
- 4. Motion Law shall prominently display the following disclosure requirements:
 - a. Innovation Office Badge
 - b. Nonlawyer ownership disclosure
- 5. This authorization is granted for the duration of the existence of the Sandbox, or until exit and permanent licensure at the discretion of the Court.
- 6. All managers and owners are hereby ordered to:2
 - a. Act in good faith to further a client's best interests.
 - b. Not allow economic or other conflicts of interest to adversely affect the legal services rendered to a client.
 - c. Ensure that legal services are delivered with reasonable diligence and promptness.
 - d. Not reveal confidential information pertaining to the representation of a client without the client's consent or as allowed or required by law.
 - e. Not engage in or allow any activity that misleads or attempts to mislead a client, a court, or others.
 - f. Not take any action or engage in activity that interferes with the professional independence of lawyers or others authorized to provide legal services.

Managers

All persons and entities who wholly or partially direct the management or policies of the entity, and/or the direct provision of legal services to consumers, whether through ownership of securities, by contract, or otherwise, including a mentor who manages the person providing the legal services. Also called "controlling persons."

Owners

All persons and entities who wholly or partially (10% or more) finance the business (i.e. the services) of the entity. Also called "financing persons."

Please note that the definition of owner/financing person does not include philanthropic funders or other investors who do not take an ownership interest in the entity.

 $^{^{2}}$ Managers and owners are specific terms defined in the Innovation Office Manual as follows:

- g. Develop systems and processes within the entity applicant to ensure that each of the above duties are met and satisfied.
- h. Complete a one-hour ethics training approved by the LSI Committee that explains these obligations.
- 7. Authorization is subject to Motion Law's compliance with the conditions and requirements set forth in the Innovation Office Manual and verification by the Innovation Office that the company's services are not causing material harm to consumers.
- 8. This authorization does not relieve Motion Law, its employees, or any associated lawyer from compliance with applicable state and federal laws and any rules or regulations of another state, government agency, or other governing body. Motion Law is responsible for assuring that it is in compliance with the laws, rules, and regulations of any other affected jurisdiction.

If Motion Law wishes to alter these conditions or requirements, it must submit any such change to the Innovation Office for further assessment. The Innovation Office will assess the proposed change and may permit the change if it deems the change does not materially increase the risks to consumers. If the Innovation Office finds a material increase in risk, then it will present the issue to the Court for further consideration.

Motion Law LLC will be a new company formed in Utah by Pearson Butler a law firm based in South Jordan Utah. Motion Law LLC already has offices in Washington DC, Phoenix Arizona and Tucson Arizona. Motion Law provides the public with free initial consultations by means of telephone or in-person consultations. Motion Law uses a law-based CRM system which also allows clients secure access via a client portal to their case status, documentation, events, invoices, and payment mechanisms. These files are available electronically but can also be accessed physically via client meetings in person at our offices. Consumers can initially access our services via several channels funded by Motion Law LLC. Our client acquisition model involves regular monthly investment in Paid for Advertising on Google through which consumers searching for immigration law services can choose to inquire via our website web-form or direct telephone contact. All legal services customers retain Motion Law LLC to undertake for them will be delivered by an Immigration Attorney with a Bar of good standing who will in turn be supported by Paralegals, Legal Assistants and Client Care representatives. Our services aim to provide customers with immigration relief by managing their processes to the best possible outcome. For some of our customers this may result in them or their family members attaining status as Legal Permanent Residents or US citizens, for others, a successful outcome may arrive via a process that prevents them from being deported while next steps are explored and implemented. Our services aim to help our customers to navigate the Immigration system and provide them with the peace of mind that their processes are in the hands of an experienced Motion Law Immigration attorney.

Motion Law will be formed in Utah as an LLC with the sole owner and 100% shareholder as Mr Andrew Haywood. As an ABS we have clearly delineated the operational management of our firm from those amongst the team who are qualified to offer or guide the public with Legal advice. Our objective is to alleviate the pressures of running a business from the shoulders of the attorneys so they can concentrate entirely on serving their clients with 100% focus on their processes and towards successful outcomes. Conversely, our business team members and operational staff are also closed out from proffering any legal advice and have clearly defined roles with which they can engage the public and clients. Both attorneys and non-attorneys (except for Motion Law's Compliance Attorney), will subscribe to the same legal disclaimer which will be amended specifically for the State of Utah, (see attached examples of our existing ABS company handbook, along with one of our Employee, Manager Declaration Agreements). The separation of these two distinct areas of the business not only allows our Attorneys to pay closer attention to advising potential new clients and existing clients, but it also allows them time to research and be more effective with their time. It creates a greater space for them to consider their codes of ethics and to investigate more diverse solutions in response to an ever-changing landscape of immigration needs. The Team at Motion Law is built on a strong foundation of expertise, knowledge, understanding and respect. Many of our team have experienced the immigration process with their own families. With this combination of both legal and personal immigration experience, we consider ourselves extremely well equipped to help our clients navigate the complexities of the US immigration process with not only best-in-class professionalism, but considerable empathy. Motion Law has an experienced management team and structure which includes Mr Andrew Haywood as the President and Owner, a CEO, a Supervising Attorney, Compliance Attorney and a Paralegal Manager This team ensures both the operational and legal pieces of the business work in perfect harmony resulting in the client getting the very best customer service and legal help and advice.

At Motion Law we strongly believe that our business model lowers the potential risk any customer may face; to a level below the level of risk they may be exposed to at a typical non-ABS legal server provider model. Because all Motion Law business operations, aside from legal advice and legal process management, are overseen by an experienced management team, Motion Law attorneys are 100% able to focus solely on providing thoroughly researched and informed legal services and advice to our customers. Flawed legal results are mitigated from end-to-end through a number of pre-retention mechanisms; initially via first point of contact customer intakes with conflict-of-interest checks, cross checks on state law nuances under the umbrella of federal law, a thorough in-consultation fact find tied with requests for proof of identification and documentation plus considered and thoroughly researched legal strategies delivered by attorneys via a series of 1st, 2nd and sometimes 3rd consultations prior to retaining.

These efforts could include quality control measures, training, provider testing.

As a retained Motion Law customer, our clients will benefit from the protection of a law firm that not only employs a dedicated Supervising Attorney whose role it is to quality control the viability and standard of legal advice and process delivery but also the guidance of a Compliance Attorney who is employed to ensure that our service model allows all of our customers to fully exercise their legal rights. Both our Compliance and Supervising Attorney are always on hand to help and assist all the attorneys at Motion Law. In addition, in order to further manage risk, our attorneys hold weekly legal meetings with fresh status reports so that they can review all active, pending and filed client cases with their legal team and ensure that case processes, regular client contacts, case tasks, events, meetings, hearings and statute of limitations are being met / observed, planned for and managed. Every month the Supervising Attorney will hold a meeting with all the Firm's attorneys to discuss and promote Best Practices whilst also holding an open Forum for discussion concerning any new rules / regulations, moves and changes, or processes that need to be determined or implemented. Each month the Compliance Attorney will hold a meeting with Mr Haywood, the CEO of Motion Law, Vice President of Motion Law, the Supervising Attorney and Paralegal Supervisor to review all compliance projects and processes to ensure all requisite laws and codes of ethics are being adhered to. All senior management and the Supervising Attorney also meet at least twice per month in order to discuss, manage and mitigate any pressure points within the practice and the pending rota of events. The format for first stage escalation with a complainant client with legal process queries is for the attorney to meet as soon as possible with them either in-person or over the phone in a client meeting in order to address their concerns. If a lead attorney is unable to fully resolve a client complaint or issue, then the complaint would then be escalated to the Supervising Attorney and the Senior Management Team. If the nature of the complaint is not legal process related but is founded on commercial or customer service-related questions, then the complaint will be escalated through the paralegal and Paralegal Supervisor to the Senior Management Team (which includes the Supervising Attorney). For any complaints which might allege or infer negligence, malpractice, or a breach of the Rules of Professional Conduct, the final point of escalation would be to consult with Motion Law's Compliance Attorney, who is available at all times to give counsel on any complaint resolution. All complaints are prioritised, High, Medium or Low and are addressed by our highly experienced Team as quickly and efficiently as possible to preserve Motion Law's prevailing goal of customer satisfaction and excellence at all times throughout our customers journey with us.


