1. DISCUSSION

Welcome & Public Comment

John Lund

John Lund welcomed the Committee and public and opened the public comment period.

Gabriela Elizondo-Craig of the Innovation for Justice lab at the University of Utah and University of Arizona explained the Community Justice Advocates of Utah (CJAU) program, which has applied for sandbox approval. Under the proposal, CJAU would work with community organizations to train non-lawyer professionals in those organizations to provide limited legal services to low-income Utahns.

Hayley Cousin of CJAU expressed her support for the application.

Ana Paula Montanha of Hayman-Woodward Human Capital LLP, an authorized entity, requested further information from the Committee on the Supreme Court's direction to pause immigration-related applications.

Noella Sudbury of Rasa Legal, an authorized entity, requested the Committee provide an update on licensure and data reporting requirements.

Tamarin Lindenberg of Lindenberg Law Group, an authorized entity, requested the Committee provide an update on licensure.

Hendrik Pretorius of Boundless Immigration, an authorized entity, introduced himself.

2. VOTE

Approval of June 2024 Meeting Minutes

Mr. Lund invited a motion for approval of the June 2024 minutes.

Lindsey Brandt moved to approve the minutes, and John Rees seconded the motion. The motion passed unanimously.

3. DISCUSSION & VOTE

Application: Community Justice Advocates of Utah

Tanya Rosado & Alyson McAllister

Tanya Rosado summarized CJAU's application and its proposed training and certification process.

Ms. Cousin of CJAU answered questions from the Committee, explaining that CJAU's partner organizations will have to independently qualify for Sandbox authorization. CJAU will vet the organizations and report the required data to the Committee. If a certified individual leaves a partner organization, CJAU will inform the organization it is no longer authorized to provide those legal services.

Mr. Lund invited **Alyson McAllister** to present the Applications Working Group's recommendation. **Ms. McAllister** noted the Working Group recommends approving the application.

Ms. McAllister moved to recommend the Court approve the application, and Rebecca Sandefur seconded the motion. The motion passed unanimously.

Following this discussion, Lindsey Brandt moved for the Committee to enter a closed session, and the Committee closed the meeting.

5. VOTE

Immigration Policy
Inquiries from Applicants

Nathanael Player and **Ms. Ricca** described the proposal to suspend consideration of applications from for-profit entities providing immigration legal services. The Committee does not have the regulatory resources to handle the high number of national entities seeking authorization. This policy would not affect nonprofit entities or currently authorized entities. In response to questions from applicants, Ms. Ricca will revise the proposal to recommend that entities affected by this policy that have already submitted applications be able to amend their applications or receive a refund.

Ms. Ricca moved to approve the draft memorandum recommendation for the Court with revisions clarifying existing applicants' ability to amend their applications or be refunded. Mr. Player seconded the motion, and it passed unanimously.

Rebecca Sandefur abstained from the vote.

6. DISCUSSION & VOTE

Jurisdictional Question

John Lund, Nathanael Player & Lucy Ricca

Ms. Ricca explained that the Court has asked the Committee to analyze the cross-border implications of authorizing entities in the Sandbox. **Ms. Ricca** presented a draft memorandum explaining the long-standing issues complicating the provision of cross-border legal services. Authorized entities should be aware that the Utah Sandbox does not authorize services outside of Utah.

Mr. Player moved to approve the draft memorandum for the Court, and Ms. Sandefur seconded the motion. The motion passed unanimously.
